On any given day, you can find Legal Aid staff preventing a family's illegal eviction, saving a disabled individual's wrongfully denied benefits, or appearing in court for a victim of domestic violence.

In the United States, low-income residents are only entitled to an attorney in criminal matters. For all other civil matters—such as unlawful eviction, denial of much needed health benefits, or domestic violence—low-income residents must hire a private attorney to navigate the courts. The national average cost for a private attorney is \$200- \$400 an hour and more than half of our clients make less than \$15,000 a year. The gap is clear. Our community's most vulnerable families are one injustice away from homelessness simply because they cannot afford to access our justice system.
